

## Immigration Services

Our immigration team has extensive experience in advising on all aspects of UK immigration and citizenship. We provide a personalised, efficient and pragmatic approach to a wide range of clients, including high net worth and ultra-high net worth individuals, their families and their businesses. Below is a list of some of the most popular applications we are able to assist with, along with indicative costs for each application type.

The work we undertake is multi-jurisdictional and complex. Because the services we offer are bespoke, the following fees should be referenced as a guide only.

### Visa and Immigration Application Fees

- Global Talent (visas for leaders in the field of science, humanities, engineering, medicine, digital technology or the arts) – **£8,000-£15,000**.
- Student – **£4,000-£7,000**.
- Youth Mobility Scheme (for 18-30 year olds with certain nationalities) – **£3,000-£7,000**.
- Global Business Mobility (Expansion Worker) – **£10,000-£15,000**.
- UK Ancestry – **£5,000-£8,000**.
- Family based applications for Spouse, Civil Partner, Unmarried Partner or Child of a British person or settled person – **£7,000-£15,000**.
- Dependant elderly relatives – **£8,000-£20,000**.
- Visit visas (business and tourism) – **£3,000-£5,000**.
- Settlement on the basis of 5 years residence in the UK – **£5,000-£15,000**.
- Settlement on the basis of 10 years long residence in the UK – **£8,000-£15,000**.
- Applications for British citizenship/registration – **£5,000-£15,000**.
- Applications under the EU Settlement Scheme and their family members – **£3,000-£7,000**.
- Innovator founder visas – **£8,000-£15,000**.
- Skilled worker – **£4,000-£8,000**.

All figures stated above exclude VAT (charged at 20%) unless specifically stated. In all cases we will provide you with an individual fee based on your circumstances once we have received full details from you.

Please also be aware that the fee ranges provided assume that you have no discretionary elements to your application, no adverse immigration history, no civil or criminal convictions or pending convictions, no non-compliance with the Immigrations Rules and that your application is not time sensitive.

## How We Charge

We would ordinarily charge on a fixed-fee basis, which will vary depending on the seniority and experience of the lawyers who will assist you with your immigration requirements. Our hourly rates range from **£185 to £565** plus VAT (charged at 20%) for our non-partner fee earners and **£585 to £910** plus VAT (charged at 20%) (if applicable) for partners. Please note that these rates may be varied.

Our legal fees will always reflect the estimate given unless new or unforeseen factors arise. If this happens, we will provide a revised estimate of our legal fees. If we are required to undertake more work and additional time is spent working on a case, our legal fees will increase.

We can provide a bespoke estimate of the likely fees of an application once we have more information and specific circumstances.

## Disbursements

We will also charge for disbursements that we pay on your behalf. This may include costs such as translation fees and courier fees and can typically range from **£30 to £500**.

In addition, applicants will be responsible for paying the following costs:

- **Home Office application fees**, which vary depending on the type of application and the duration of the visa and are subject to change at any time;
- **Appointment and submission costs**, set by the Home Office's commercial partner, which vary depending on the location and method of submission and whether a priority service is selected;
- **Immigration Health Surcharge (IHS)**, which is payable for most applications involving a stay of longer than six months.

Additionally, applicants may also incur costs for the following (please note, however, that the below is not an exhaustive list of all possible costs and they do not apply to every type of application):

- Criminal Record Certificate
- Evidence of English
- Tuberculosis Testing
- Subject Access Request
- Life in the UK Test

## What services do we offer?

The work will typically involve:

- Taking your initial instructions and discussing particular circumstances in detail and confirming whether this is the most appropriate application to make and what other options may be available;
- providing advice about the requirements of the relevant rules and whether the criteria is met;
- if certain criteria are not met, whether this can be overcome and how;
- providing a detailed strategy, relevant time frames, details of documents required to support the application and details of the application process;
- considering the supporting evidence provided and drafting the application form;
- where necessary, helping obtain further evidence including bank letters, bank statements etc.;
- preparing the application for submission including booking your appointment to submit your biometrics and application bundle;
- drafting a detailed letter of representations setting out how you meet the requirements for a visa to be granted to you;
- providing you with advice and instructions in respect of submitting your application and assisting to prepare you for an interview (if required);
- providing advice about the outcome of the application and instructions for complying with your immigration conditions.

Please note that the fees set out above do not include the costs of any appeals or administrative reviews. These would be charged additionally.

## How long will my application take?

The time taking preparing your application will depend on the complexity of your case and how quickly we receive the required supporting evidence from you.
